To apply for a Demolition Permit, you MUST provide this Application filled out, a check payable to the Village of Oriskany for the application fee, and One (1) copy of a Plot Plan.

No permit will be issued by the Code Enforcement Officer to authorize the demolition, in whole or in part, of any building or structure other than single-family homes, where owner is performing work, New York State Department of Labor must be contacted and an asbestos survey was performed.

Industrial Code Rule 56, "Asbestos."

Requires asbestos survey prior to any demolition activities on building, with specific exceptions. Provides requirements for asbestos abatement.

The Code Enforcement Officer will not issue a permit until negative declaration of asbestos or without confirmation from the New York State Department of Labor, that the contractor has contacted them.

Demolition is defined as:

The work incidental to or associated with the total or partial dismantling or razing of a building or structure including the removing or dismantling of machinery or other equipment.
